It is an unique, innovative and creative ideal dream project of the Society as well as Sangeet Natak Akademi, a positive attempt for Self-betterment of 30 numbers of OoSTC under the age group of 18 years to make them financial independent though using / training of Tribal / Folk / Classical / Contemporary Dance and Music forms through organize of a complete proposal of self-employment oriented with income generated skill development Tribal Children Workshop (Workshop on, Dance & Music Training) with OoSTC to upbuild / make an Unit of "RANG" AKHAADAA" (A Complete & Developed form of OoSTC Professional Dance Troop) through hire experts from New Delhi, West Bengal, Odisha and from the Local Area to trained & well-build the participated children in this Workshop to make performances throughout in India & abroad for their betterment, attempt to create self-employment and, the Society will also try to find out something new ways to make them able financial independent.
